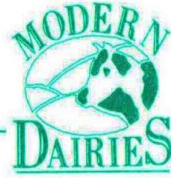

2. DEFINITIONS

- C. **Familiarisation Programme means** (The Program) formulated by Company.
- D. **SEBI Listing Regulations** means Securities Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.

3. FAMILIARISATION PROGRAMS

- The Company through its designated personnel, including the Chairman and Managing Director and Key Managerial Personnel, shall conduct orientation programs and give presentations to familiarize Independent Directors with the Company's vision, strategy, operations, business environment, regulatory updates and key functional areas. This will provide them with a thorough understanding of the Company's workings. Furthermore, Independent Directors will also be familiarized with important statutory and regulatory provisions, as well as Company policies applicable to them, enabling them to effectively discharge their duties in compliance with relevant laws and regulations.

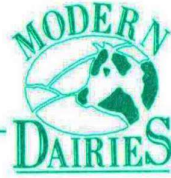

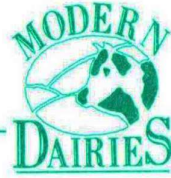
